



VERSION 2:¹ Charter School COVID-19 Vaccination Compliance Certification Regarding Employees and Other Adults Providing Services on District Property

In accordance with Los Angeles Unified School District (the "DISTRICT") requirements or policy, all charter school employees² (and/or other adults³) who provide services on DISTRICT property⁴ must be vaccinated against COVID-19 and receive their 1st dose of the Moderna or Pfizer vaccine or their single dose of the Johnson & Johnson vaccine by October 15, 2021, and as applicable, receive their 2nd dose of the Moderna or Pfizer vaccine by November 15, 2021.

PLEASE BE ADVISED THAT NO FURTHER ACTION IS NEEDED FOR ALL CHARTER SCHOOLS THAT HAVE ALREADY COMPLETED, SIGNED AND SUBMITTED THE CERTIFICATION FORM THAT WAS PREVIOUSLY SENT BY THE CHARTER SCHOOLS DIVISION ON OCTOBER 5, 2021. IN SUCH CASE, YOU DO NOT NEED TO COMPLETE, SIGN AND SUBMIT THIS FORM BECAUSE THE FORM PREVIOUSLY SUBMITTED WILL SERVE AS THE CHARTER SCHOOL'S RECORD OF COMPLIANCE CERTIFICATION PURSUANT TO THE TERMS SET FORTH IN THAT PREVIOUS FORM SENT ON OCTOBER 5, 2021.

The CHARTER further certifies to the DISTRICT that all of the CHARTER's employees and other adults who provide services on DISTRICT property, who have NOT received their 1st dose of the Moderna or Pfizer vaccine or their single dose of the Johnson & Johnson vaccine by October 15, 2021, will NOT access or enter any DISTRICT property after October 15, 2021.

¹ Consistent with updated DISTRICT policy or requirements, as of October 11, 2021, the DISTRICT adjusts the applicable deadline for vaccination compliance in order to ensure that all school employees (and/or other adults) who provide services on DISTRICT property are able to be vaccinated with the COVID vaccine of their choice.

² "Employees" is interpreted broadly to include, but not be limited to, any permanent/substitute teachers, aides, staff, administrators, board members and officers.

³ "Other adults" is interpreted broadly to include, but not be limited to, any partners, contractors, subcontractors, agents, volunteers, interns, and other representatives, regardless of paid status.

⁴ "DISTRICT property" is interpreted broadly to include, but not be limited to, any District-owned or leased property, such as any co-located school site, sole occupant school site, etc.

The CHARTER further certifies to the DISTRICT that all CHARTER employees and other adults who provide services on DISTRICT property, who received their 1st dose of the Moderna or Pfizer vaccine by October 15, 2021, will receive their 2nd dose of the Moderna or Pfizer vaccine by no later than November 15, 2021.



The CHARTER further certifies to the DISTRICT that all of the CHARTER's employees and other adults who provide services on DISTRICT property, who received their 1st dose of the Moderna or Pfizer vaccine but failed to receive their 2nd dose of the Moderna or Pfizer vaccine by November 15, 2021, will NOT access or enter any DISTRICT property after November 15, 2021.

PLEASE BE ADVISED: the CHARTER's failure to accurately certify and submit this form by October 15, 2021, and/or fully comply with all of the terms of the DISTRICT requirements or policies and this form at all times, shall constitute, among other things, a violation of the CHARTER's operative charter, material breach and/or default of the CHARTER's applicable facilities agreement, and/or the CHARTER's noncompliance with applicable law. In such event, the DISTRICT may exercise any and all available actions and/or remedies, including, but not limited to, recommendation for revocation of the CHARTER's operative charter, removal of persons and personal property from the DISTRICT premises, termination of the CHARTER's right to occupy DISTRICT premises, and/or any activity to mitigate the impact of the CHARTER's failure, with all costs incurred by the DISTRICT in so performing to be reimbursed by the CHARTER. The DISTRICT reserves all rights pursuant to its oversight authorities and obligations, and otherwise, to fully enforce DISTRICT requirements or policies and the terms in this form.

By signing below, under penalty of perjury, the CHARTER hereby certifies that the information checked above is accurate and that it may be uttered or published as true. The CHARTER further understands that, upon request, it will provide the DISTRICT with any and all documents/records demonstrating that the CHARTER is appropriately monitoring its employees and other adults who provide services on DISTRICT property, relating to the CHARTER's compliance with DISTRICT requirements or policies, applicable legal requirements, and this form.
